Announcement of Full-Time Position Faculty of Humanities, Institute of Human and Social Sciences Kanazawa University

- Number of positions: One Associate Professor (tenured) or Lecturer (five-year fixed-term contract*)
- * The term of Lecturer is set for 5 years at the time of employment. The candidate will be converted to adequate tenured status, based on the following achievements, which is to be implemented during the term.
 - (1) Educational achievements (Lecture, Practicum, Seminar, Research guidance, etc.)
 - (2) Research achievements (Research papers, Presentations at conferences, Research grants, etc.)
 - (3) Contribution to the university and society, and so on

2. Affiliation:

- (1) Research body: Faculty of Humanities
- (2) Educational body: School of Humanities and Graduate School of Human and Socio-Environmental Studies
- *You will have to participate in (cooperative) research projects in the field of Psychological Science.
- 3. **Field of specialization**: Clinical Psychology (Medical and Health Area)

4. Subjects to Teach:

- General Education Division: lectures and seminars
- School of Humanities: Seminar in Psychology, Practical Training in Psychology, and other lectures and seminars corresponding to Licensed Psychologists
- Graduate School of Human and Socio-Environmental Studies: Support Theory and Applications in Medical and Health Area, Practicum in Psychology and other lectures and seminars

5. **Qualifications**:

All of the following requirements must be fulfilled:

(1) Have three or more years of full-time (or part-time) teaching experiences for students' practical training and seminars of psychology in university programs

- (including graduate programs, two-year college or specialized training college programs).
- (2) Have a "Licensed Psychologists" license (a clinical psychologist license issued by the Japanese Ministry of Health, Labor and Welfare) or have a plan to obtain the license. We further welcome licensed clinical psychologists issued by the Foundation of the Japanese Certification Board for Clinical Psychologists.
- (3) Have experiences of clinical psychotherapies in medical and health area.
- (4) Those who are enthusiastic and proactive in the training and education of licensed psychologists at Kanazawa-University.
- (5) An applicant of any nationality can be considered. A command of Japanese sufficient to lecture, hold seminars and attend meetings is required.
- (6) Residence in Kanazawa or surrounding cities after employment.
- 6. **Deadline for application**: June 20, 2025
- 7. **Commencement of employment**: October 1st, 2025 or the earliest possible date thereafter

8. Application documents:

- (1) Curriculum vitae
- (2) List of research achievements
- (3) Acquisition of external funds, contribution to society, etc.
- (4) List of educational achievements
- (5) Clinical experiences:
- ① List of clinical activities. Necessary to include (i) your major area ("Social Welfare", "School and Education (including counseling institutions in the university)", "Medical and Health", "Forensic and Criminal", and "Industrial and Organizational"), (ii) period of activities, (iii) subject person for the clinical support in your activities, and (iv) your position of the activities.
- ② Summary of your major activities in clinical psychology (In Japanese, case reports and so on, approximately two A4-sized pages)
- ③ Lists of experience in providing supervision to graduate students, support workers, etc.(Specify what agency or field, for how long, and to what subjects you conducted your supervision).
- (6) Ambitions and plans for future education of "Licensed Psychologists" (approximately 1,000 characters in Japanese)
- (7) Within five* major publications and their summaries (for each publication,

approximately 1,000 characters in Japanese).

- * For Associate Professor, just five publications and summaries are required.
- (8) Information of one or more reference persons (name, affiliation, e-mail address, phone number and relationship to the applicant).
- (9) If you have following licenses. A copy of document that can prove that you have a "Licensed Psychologists" or "Clinical Psychologist" qualification.
- (10) If you have completed the Training Program for Practical Training Instructors of Licensed Psychologists or the Training Program for Supervisors of Practical Training for Licensed Psychologists, please submit a copy of the certificate. If you have not completed those courses, you will be required to take the courses as soon as you start working at the university.

9. Selection process:

The selection will be based on the submitted documents. After the initial screening, short-listed candidates may be called for an interview and be asked to give a 30-minute teaching demonstration (15 minutes in English, 15 minutes in Japanese). Travel costs (including overseas travel) for the interview will not be covered.

10. **Destination of the documents:**

The application documents should be submitted online (JREC-IN Portal Web). Please convert all documents to PDFs, put them together in one ZIP file, and submit it via the JREC-IN Portal site.
